Kyle called the meeting to order at 7:07pm.

MINUTE APPROVAL

Kyle motioned to approve the minutes of February 14 as written, Ron 2nd, so voted.

OLD BUSINESS

Town Clerk Cabinets

Kyle will stop by Ashland Lumber to pick up the lumber for bracing the floor. The lally columns are here. Kyle and Miles will work on the project on Saturday.

2012 Warrant/Budget

Kyle motioned to sign the 2012 Warrant, Ron 2nd, so voted. The Department of Revenue had some suggestions for language changes for articles 2, 3 and 22. These changes did not alter the dollar amounts or funding for these articles.

Mr. Faucher ultimately agreed that he could get it taken care of within 2 weeks. It appears as though he might be sending the Board a letter (email) committing to this. Kyle does not feel that they should send out another letter. He believes two weeks from today is good for a deadline, and they should give him until the deadline to clean up before contacting him again. There was some discussion regarding when the 30 days expires. Miles agreed that they should not give him any additional time above the 2 weeks mentioned today or the original 30 day deadline if it is further out than two weeks. The Board agreed.
