Slim Spafford asked if there would be proper salt sheds constructed on the new Town Garage lot. The Board explained that the Road Agent is aware of the need to have proper shed(s), and that even though the shed(s) will not be a part of the grant (FEMA will not cover this) it is a requirement that the salt be housed on an impermeable surface.

The Board announced that Groton Wind has begun to bring in turbine sections. The Company would like to bring in 3 turbines per week.

Betty Smolinsky stated that early in the morning there are some trucks coming over the hill from the direction of the Town House traveling very fast. Christina urged her to leave a message with the Police Department.
