## **Audience Members Present**

John called the meeting to order at 7:02pm.

## **MINUTE APPROVAL**

John motioned to approve the Work Session Meeting minutes of September 17, 2019 as written, Tony 2nd, so voted.

John motioned to approve the Non-Public Work Session Meeting minutes of September 17, 2019 as written, Tony 2nd, so voted.

John motioned to approve the Select Board Meeting minutes of September 17, 2019 as written, Tony 2nd, so voted.

## **NEW BUSINESS:**

Wex- Notice of Federal Tax Exemption Expiration/Certificate of Buyer

Each year Wex sends the notice of federal tax exemption expiration along with a new certificate to sign. **John motioned to sign the Wex certificate of buyer, Tony 2nd, so voted.** 

Local Septic Approval- Map 5 Lot 26-1

Daniel Ward dropped off a Septic Plan and local approval for Map 5 Lot 26-1. All the information is correct. **John motioned to sign the local approval for Map 5 Lot 26-1, Tony 2nd, so voted.** 

Building Permit Map 1 Lot 53-1

The owner submitted a building permit for a 10x20 shed. This will not be heated or cooled. **John motioned to sign the building permit for Map 1 Lot 53-1, Tony 2nd, so voted.** 

# Stream Restoration Conference

The Town received an email about a conference on stream restoration on October 17<sup>th</sup>, 2019 from 8:00am-4:00pm at Gunstock Mountain Resort. Sara was wondering who should attend and who she should sign up for this. Slim was in attendance and it was agreed that Slim will attend and can report what he finds back to the Select Board. Sara will sign him up.

#### 7 Patterson Lane

The Town received a call that lumber was delivered and construction was taking place at 7 Patterson Lane. There is no building permit on file. John motioned to sign the letter requesting a building permit be submitted or clarification be provided, Tony 2<sup>nd</sup> so voted.

Temporary road, landing and skid trail use agreement

In December 2018, Bob Berti met with the Select Board and entered into an agreement for Green Acre Woodlands, Inc. to temporarily use Tax Map 10, Lot 40 to remove forest products from their property (Tax Map 10, Lot 42) until March 31, 2019. They were unable to complete the timber sale this past winter. Bob

would like to enter into another temporary use agreement with the Town of Groton until March 31, 2021. Green Acre Woodlands sent a revised agreement for review and signature. If the Board would like to meet with Bob to discuss the agreement, we can let him know. John motioned to sign the Temporary road, landing and skid trail use agreement with Green Acre Woodlands, Tony 2<sup>nd</sup>, so voted.

Amended Local Septic Plan Approval, Map 1 Lot 13-1

Eleanor Myles dropped off an amended Septic Plan and local approval for Map 1 Lot 13-1. It is just a change to the location. All the information is correct. **John motioned to sign the amended local approval for Map 1 Lot 13-1 & 2, Tony 2nd, so voted.** 

NH Police Standards and Training Forms (A&I)

The Grafton County Sheriff's Department completed a background check on the potential hire. The Select Board will review this. In the meantime, there are two forms that need to be sent in to New Hampshire Police Standards and Training Council, which are the Employee Status Notification Form "A" and the Council Form "I", the Affidavit of background investigation. **John motioned to sign both Form "A" and Form "I", Tony 2**<sup>nd</sup>, so voted.

HealthTrust- Secure Member Portal

HealthTrust sent a secure member portal authorized users certification form for the Select Board to sign. Sara Smith is the only one that uses this portal. **John motioned to sign the secure member portal authorized user's certification form, Tony 2nd, so voted.** 

Intent to cut- Map 10 Lot 42

The Town received an Intent to Cut for Map 10 Lot 42 for a 40-acre cut. There are no taxes owed on the property so a bond was not required and all information on the intent is correct. **John motioned to sign the Intent to Cut for Map 10 Lot 42, Tony 2nd, so voted.** 

### **SELECT BOARD ITEMS:**

Amended Local Septic Plan Approval, Map 1 Lot 51

Matt Barnard dropped off an amended Septic Plan and local approval for Map 1 Lot 51. It is just a change to the location. All the information is correct. **John motioned to sign the amended local approval for Map 1 Lot 51, Tony 2nd, so voted.**

Highway Department

Bubba went over the following items regarding the Highway Department:

- Edgar Albert Road had work done and was brought back to pre-storm conditions.
- Sara and Bubba met with FEMA today. They visited all roads that were damaged in the July storm with FEMA and HSEM.
