November 1, 2022

**Audience Members Present**

John called the meeting to order at 7:00pm.

**MINUTE APPROVAL**

John explained that they will need to table the minute approval until Tony returns at the next meeting. This is because Tony is not at this meeting and Ron would need to abstain from 10/4/22 minutes and John would need to abstain from 10/18/22 minutes since they were not at those meetings. **John motioned to table the minute approval until Tony returns at the next meeting, Ron 2<sup>nd</sup> so voted.**

**OLD BUSINESS:**

*Building Permit- Map 6 Lot 63-6*

The owners submitted a building permit for a 28x56 house at 30 Old Fields Road. This is on a private road so Sara submitted this to the Planning Board for review and they did review it at the last meeting. They did submit the private road release; the date just needs to be amended. They will need to be aware of the restrictions on the property. **John motioned to approve the building permit for Map 6 Lot 63-6, Ron 2<sup>nd</sup>, so voted.**

*Building Permit- Map 2 Lot 71*

The owners submitted a building permit for a small mudroom addition at 20 MacDonald Lane. This is on a private road so Sara submitted this to the Planning Board for review and they did review it at the last meeting. They already have a recorded release on file. **John motioned to approve the building permit for Map 2 Lot 71, Ron 2<sup>nd</sup>, so voted.**

*Local Septic Approval- Map 6 Lot 47*

Richard Gowen dropped off a local septic approval for Map 6 Lot 47, for a resident on Giovanna Road. All information is correct. **John motioned to sign the local septic approval for Map 6 Lot 47, Ron 2<sup>nd</sup>, so voted.**

*MS-60W*

This is a waiver request for the locally elected audit that allows towns, under population of 700, to request permission to complete sections 1 and 2 only for the audit. **John motioned to sign the MS-60W, Ron 2<sup>nd</sup>, so voted.**

**SELECT BOARD ITEMS:**

*Reported Street Light*

John informed the Town that they are aware that the street light is out at the intersection of North Groton Road and Sculptured Rocks Road. Sara did report this and we are waiting for NHEC to take care of it.
